Implementation of the Annual Transfers of Officers belonging to All Island services, serving in Line Ministries and Departments

If it is decided that it is essential to further obtain the service of a certain officer, belonging to an All Island service, who has been identified as an officer who plays a significant role in the implementation of development programmes initiated by the government, continuously and effectively, to the relevant ministry/ department, the Secretary of the respective line ministry shall be vested with the power, subjected to acting in the following manner, to retain the relevant officer further in the current service station until 31st December 2020 without transferring him under annual transfers, in terms of the decision of the Cabinet of Ministers No. CP/18/2036/805/062 dated 19.09.2018.

02. Action should be taken to submit a request to retain further the relevant officer in the current service station, prepared as per the format given herewith, along with the written concurrence of the said officers and observations and recommendations of the respective administrative authority, to the public service commission.

03. If the relevant officer has received a transfer under annual transfers 2019, the relevant request should be submitted to the Public Service Commission on or before 15.11.2018.

04. If the relevant officer is engaged in the provincial public service, the above requests should be submitted to the Public Service Commission by the relevant Chief Secretary of the province.

05. Action should be taken to ensure that requests are made under this circular only at occasions where it is very important and essential to retain a certain officer, in order to minimize the inconveniences that can be faced by officers who have been serving in remote/ unpopular service stations and are expecting transfers to convenient/ popular service stations under annual transfers.

06. Action should be taken by the relevant administrative authority to publish the details of officers whose transfers are cancelled under this circular, in a suitable manner, for information of the other officers of the said all island services.
