8.2 How often are examinations held ? Efficiency Bar Examinations will be held twice a year.

- 10.3.1 Appointment to Special Grade is approved by the Public Service Commission only by promoting officers of the Grade I who have fulfilled the following requirements.
 - i. Should have obtained a Post Graduate Degree in relevant field.
 - ii. Should have completed five (05) years of active and satisfactory service in Grade I of the Executive service Category and should have earned five increments after promotion to Grade I as at the date of gaining eligibility for promotion.
 - iii. Should have completed not less than 18 years of active service period in the Executive service Category of the related service category/posts as at the date of gaining eligibility for promotion.
 - iv. Should have attained a performance at satisfactory level or above within the period of 05 years immediately preceding to the date of gaining eligibility for promotion.
 - v. Should have a satisfactory service period and should not have been subjected to disciplinary punishment within the period of 05 years immediately proceeding to the date of gaining eligibility for promotion.

Officers will be promoted as per the existing vacancies having considered the seniority and merit after an interview approved by the Public Service Commission.
