Government Translators' Service, Sri Lanka Information and Communication Technology, Public Management Assistants' Service, Sri Lanka Librarian Service, Office Employees' Service, Combined Drivers' Service

I hereby grant approval for the transfers indicated in the Schedule attached herewith to be effective from 01.01.2016 or the date mentioned against the names of the officers. Kindly notify the relevant officers of the Ministry/ Department in this regard and inform them to assume duties at the new service station on the prescribed date. It is informed that the transfers of the officers who have been transferred to Public Service Commission/ Commission to Investigate Allegations of Bribery or Corruption/ Department of Elections should be implemented subjected to the concurrence of the respective Heads of the Institutions.

02. Traveling expenses shall not be paid for these annual transfers to the officers who have not completed the prescribed period at the present service station. Traveling expenses should be paid to the officers who have completed the prescribed period at the present service station subjected to the provisions stipulated in the Establishments Code. Subsistence allowance shall not be paid.

03. If transfer orders are issued by the Internal Transfer Boards of your Ministry/ Department to officers who are subjected to Combined Services transfer orders for internal transfers, Combined Services transfer orders should be implemented. However, if you are of the view that the transfer orders made by the Ministries/ Departments on the requirements of Ministries/ Departments depending on the requests made by the officers should be implemented, further instructions may be obtained regarding the request along with your recommendations before the date mentioned in Para.6 of this letter.

04. The transfer procedure followed by the Transfer Committee when making these transfers has already been sent to you along with the Combined Services Circular No. 03/2015 dated 16.06.2015. The transfer orders attached herewith should be informed to all the officers who have requested for transfers. In case an officer subjected to these transfer orders has received a transfer order issued earlier, but postponed up to 31<sup>st</sup> December 2015, the previous order should be treated as null and void, if another transfer order has been given under annual transfer orders in 2016.

05. Submission should be made to the review committee for annual transfer proposals only if the requests for transfers have not been considered by the annual Transfer Committee as per the provisions in Para. XVIII of Procedural Rules (Volume I) of the Gazette Extra ordinary of No. 1589/30 of the Public Service Commission or Combined Service Circular No. 3/2015 or Procedure of Transfer and further <u>as per the matters</u> mentioned in 6.2 of Combine Service Circular No. 3/2015. Decisions for annual transfers will not be postponed after the prescribed date due to appeals/ grievances or the recommendations of the Head of the Department, which are made after the decisions made by the Public Service Commission regarding the appeals made again after the Secretary of the Public Service Commission No. PSC/APL/07/14/2013 dated 13.09.2013. The decisions made by the Public Service Commission regarding an appeal on annual transfers should be implemented unless any order has been given preventing the implementation of the transfer order.

06. A specimen for making submissions (CS/AT/04) is attached herewith. Kindly note to send the applications prepared as per said specimen before 02.11.2015 to consider the requests. (Use both sides of the paper for the application) Officers should be informed that the requests made after the above date and the applications which do not contain the employer number mentioned against the relevant officer in the transfer list will not be considered.

07. You are hereby informed to release the officers transferred outside your Ministry/ Department enabling them to assume duties at new service station on due date <u>without</u> <u>retaining them until successors report for duty</u>. Kindly note that these transfer orders should be implemented without delay. You are further informed that action can be taken as per Section 8.8 of the Circular No. 3/2015 against the officers who ignore these transfer orders without obtaining proper approval.
