**REVENUE ESTIMATES FOR YEAR 2027 FOR REVENUE CODE 20.02.01.01, RENT
ON GOVERNMENT BUILDINGS & HOUSING**

Your attention is drawn to Circular No:01/2015 dated 20.07.2015 issued by the Department of Fiscal Policy and revisions made to the same, which consist of guidelines in respect of estimating, collecting, supervising and reporting government revenue.

Therefore, you are kindly informed to prepare estimates on revenue expected to be collected by your office for the year 2027 under revenue code 20.02.01.01, revenue of rent on government buildings & housing, as per the annexed format and submit the same to this Ministry on or before 30.06.2026.
