Providing relief for the efficiency bar examination prescribed for development officers recruited on 03.01.2022 and 01.04.2022 - Development Officers' Service

Reference the Public Service Commission Circular No. 01/2023 and the letter of the Secretary of the Public Service Commission No. PSC/APP/13/4/33/2023 dated 08.08.2024 on the above matter.

02. As informed by the above letter, since the due date for passing the first efficiency bar examination prescribed for development officers recruited on 03.01.2022 and 01.04.2022 falls after 30.06.2024, those officers are able to pass the efficiency bar examination prescribed for officers in Grade III within three consecutive sittings as per the provisions of Public Service Commission Circular No. 01/2023. Therefore, if the officers recruited to the Development Officers' Service in 2022 pass the first efficiency bar examination within first three consecutive sittings (including the sittings of the examination to be held in the future) from the date of appointment, please be informed that actions will be taken to grant the due period of relief for passing the first efficiency bar examination to such officers and confirm them in their appointment to the Development Officers' Service.

03. However, it is not possible to pay the third salary increment to the officers who did not pass the first efficiency bar examination within the probation period until they pass the said examination. Action should be taken to suspend the third salary increment until such time. If the officers pass the efficiency bar examination prescribed for officers in Grade III within three consecutive sittings, action can be taken to pay the salary increment that was suspended. Therefore, you are kindly informed to refrain from referring to me the requests for relief for efficiency bar examinations made by the officers who pass the first efficiency bar examination within three consecutive sittings of the examination.
