Change of Designations of the officers, who are promoted to Grade II of All Island Services, in accordance with Grade Promotions

You are kindly informed that it has been notified by the letter of Secretary, Public Service Commission No: PSC/EST/05-05/01/2018 dated 07.02.2022 that the Commission has ordered to act in the following manner with regard to the change of the designations of the officers, who are promoted to Grade II of All Island Services of which administrative power is vested in the Secretary of the Ministry of Public Services, Provincial Councils and Local Government, in accordance with the Grade promotions.

- I To take action for the change of designation in accordance with the Grade promotions by the Head of the Institutions of the Service Stations where officers serve, if the approval has been granted taking into account the relevant posts as combined posts in Grade III and II and further the change of designation has been made depending on the Grade to which the officer holding relevant post belongs.

II To revise the designation to be effective from the date of promotion to Grade II or date of appointment to the post, whichever occurs later, in case where the officer has continuously served in the relevant post when changing the designation in the said manner.

03. Further, it should be noted that the above decision shall not be applicable to the officers, who have been recruited to the Sri Lanka Planning Service on supernumerary basis and the decisions of the Public Service Commission with regard to the said officers shall remain unchanged.
