Calling information regarding the officers who were serving as at 01.08.2011 in a post of the provincial public service to which the salary was granted under the salary scale MN4-2006(A) and later were absorbed into the Development Officers' Service due to having transferred to a post of the Central Government service as per Public Administration Circular No. 16/2010(I)

The officers who were engaged in the provincial public service as at 01.08.2011 in a graduate post receiving salary under the salary scale MN4-2006(A) as per the provisions of Public Administration Circular No. 10/2012(III) and later were transferred to a post of Development Officer of the Central Government Service as per Public Administration Circular No. 16/2010(I), having expressed their consent to be absorbed into the Development Officers' Service, were absorbed into the said service with effect from 01.08.2011 in terms of paragraph 14 of the Development Officers' Service Minute.

02. Even though the absorption of officers, who were transferred to a post of Development Officer of the Central Government Service after 01.08.2011, into the post of Development Officer under the Combined Service should come into effect from the date of assumption of duties after being transferred to the post of Development Officer of the Central Government Service, certain officers have been absorbed into the post of Development Officer of the Combined Service with effect from 01.08.2011. Therefore, you are kindly notified that it has been informed by the letter of the Secretary of the Public Service Commission No. PSC/EST/08-05/02/2022 dated 14.03.2023 that action should be taken to revise the letters of absorption issued to those officers and absorb them into the Development Officers' Service to be effective from the date of transfer to the post of the Central Government Service as per the provisions of paragraph 06 of the Public Service Commission Circular No. 04/2020.

03. Accordingly, you are kindly informed to prepare the particulars of the officers in your ministry/department/office who were engaged in the provincial public service as at 01.08.2011, then transferred to a post of the Central Government Service, and have been absorbed into the Development Officers' Service of the Combined Service as at 01.08.2011 in

accordance with the following format and submit the same to me before 30.07.2023 in order to revise the letters issued to those officers for absorption into the Development Officers' Service.
