All officers who have satisfied the relevant qualifications should appear for a structured interview as per the guidelines for interviews mentioned in Public Service Commission Circular No. 04/2023, and marks will be allocated under the following criteria. (Further details are mentioned in Public Service Commission Circular No. 04/2023.)
