Issuance of the results of the efficiency bar examinations of the officers of the Sri Lanka Information and Communication Technology Service

The results of the efficiency bar examinations of the officers of the Sri Lanka Information and Communication Technology Service are published on the website of this ministry, and in addition, each officer is informed separately.

02. Issuing the results of the efficiency bar examinations to officers separately has been found to be a task that is time-consuming, not essential and that incurs an additional cost. It has also been observed that since the heads of the institutions are also accustomed to taking action based on the results issued separately to each officer in carrying out the establishment activities of the officers, in cases where a letter containing the result is misplaced, unnecessary delays occur when dealing with it again. Therefore, you are kindly informed to take action in the following manner in the future, and I would also like to inform you that henceforth the results of the efficiency bar examinations will not be issued separately at the level of ministries, departments and offices.

- I. The results of the efficiency bar examinations prescribed for all classes and grades of the officers of the Sri Lanka Information and Communication Technology Service, which are published in gazette notifications by the Director General of Combined Services and conducted by the Sri Lanka Institute of Development Administration, will be published on the website of this ministry in the manner carried out to date..
- II. Accordingly, please take action to issue the results with your signature to the officers of the Sri Lanka Information and Communication Technology Service who are serving in your institution and appeared for the relevant examination, according to the said results sheet. It is sufficient to send me a certified copy of that letter along with the relevant documents when establishment matters pertaining to confirmation, promotion, etc. of the relevant officer are referred to me.
- III. It is compulsory to include in the personal file of the officer a photocopy, certified by you, of the results sheet containing the officer's name, which was obtained from the website of the ministry.

IV. Since action will be taken to publish the results of the efficiency bar examinations on the website of this ministry in the manner carried out to date, please inform the relevant officers that they should pay personal attention in this regard.

03. Please take action adhering to the above instructions with regard to the results of the efficiency bar examinations of the officers in Grade I of Class 3, Grade II of Class 3 and Grade III of Class 3 of the Sri Lanka Information and Communication Technology Service held on 04.06.2023, 10.06.2023 and 11.06.2023, which have been published on the website of this Ministry.

04. The manner in which the passing/failing of each efficiency bar examination is determined according to the Minute of the Sri Lanka Information and Communication Technology Service is indicated in the annex attached herewith, for your convenience.
