SRI LANKA SCIENTIFIC SERVICE MINUTE

THE following revisions shall be made to the notification published under the above heading in the *Gazette Extraordinary* of the Democratic Socialist Republic of Sri Lanka No. 1877/27 dated Thursday 28th August 2014 under Government Notification and the other facts and conditions stipulated in the same shall remain unchanged.

01. Table 6.1 in page 2A shall be rectified in the following manner.

02. “Combined number of officers : 548(III, II, I) stated under Section 6.2 in page No. 2A shall be revised as “combined number of officers : 563 (Grade III, II and I)” and other facts shall remain unchanged.

03. Paragraph 14.1 in page No. 7A shall be revised as “However, no change shall be made on the salary and the date of salary increment of the officer due to the absorption and the said date shall remain unchanged as the previous



salary increment date. Further, in the salary conversion the relevant officer should not be placed on the next higher salary step as per Section 4.4, Chapter VII of the Establishment Code as a result of falling the last drawn salary step corresponding to the new salary step.”

04. Provisions included under 14.1 (iv) of English translation regarding absorption of special grade shall be cancelled.
