6TH AMENDMENT

Service Minute of the Sri Lanka Administrative Service

THE Service Minute of the Sri Lanka Administrative Service published in the *Gazette Extraordinary* No. 1842/2 dated 23rd of December 2013 of the Democratic Socialist Republic of Sri Lanka as amended by the *Gazettes Extraordinary* No. 1923/47 dated 16th of July 2015, No. 1979/33 dated 11th August 2016, No. 2086/22 dated 30th of August 2018, No. 2095/9 dated 30th of October 2018 and No. 2095/48 dated 2nd of November 2018 of the Democratic Socialist Republic of Sri Lanka is amended as follows and these amended provisions will be made effective from 26th of February 2019, the date on which the Cabinet of Ministers made the policy decision.

13.1.1(a)

- (ii) Should have completed at least six (06) years of active and satisfactory period of service in Grade III of the category of service and earned six (06) salary increments.
- (iii) Should have demonstrated a performance at satisfactory level or above during six (06) years immediately preceding the date of promotion in accordance with the approved procedure or performance appraisal.



13.2(a)

- (ii) Should have completed at least six (06) years of active and satisfactory period of service in Grade II of the category of service and earned six (06) salary increments.
- (iv) Should have demonstrated a performance at satisfactory level or above during six (06) years immediately preceding the date of promotion in accordance with the approved procedure of performance appraisal.

The following note will be included below the qualifications referred to under 13.2 (a).

Note

The officers who are to be promoted to Grade II and have completed the qualifications referred to in the amended 13.1.1(a) as at 26th of February 2019, the date on which the Cabinet of Ministers made the policy decision and the officers who were promoted to Grade II prior to such date will be promoted to Grade I from the date they complete a period of 12 years of active and satisfactory service in Grade III and II and all other qualifications referred to under 13.2(a) excluding the qualification in 13.2(a) (ii).
