**Service Minute of the Sri Lanka Accountants Service**

THE Service Minute of the Sri Lanka Accountants Service published in the *Gazette Extraordinary* No. 1670/33 dated 10th of September, 2010 of the Democratic Socialist Republic of Sri Lanka as amended by the *Gazettes Extraordinary* No. 1695/15 dated 01st of March 2011, No. 1865/36 dated 06th of June, 2014, No. 1981/99 dated 27th of August 2016 and, No. 2070/7 dated 09th of May 2018 of the Democratic Socialist Republic of Sri Lanka is amended as follows and these amended provisions will be made effective from 26<sup>th</sup> of February 2019, the date on which the Cabinet of Ministers made the policy decision.

10.1.1.1

- (i) Should have completed at least six (06) years of active and satisfactory period of service in Grade III of the category of service and earned six (06) salary increments.



- (vi) Should have demonstrated a performance at satisfactory level or above during six (06) years immediately preceding the date of promotion in accordance with the approved procedure or performance appraisal.

10.2.1.1

- (i) Should have completed at least six (06) years of active and satisfactory period of service in Grade II of the category of service and earned six (06) salary increments.
- (iv) Should have demonstrated a performance at satisfactory level or above during six (06) years immediately preceding the date of promotion in accordance with the approved procedure of performance appraisal.

The following note will be included below the qualifications referred to under 10.2.1.1

*Note*

The officers who are to be promoted to Grade II and have completed the qualifications referred to in the amended 10.1.1.1 as at 26<sup>th</sup> of February 2019, the date on which the Cabinet of Ministers made the policy decision and the officers who were promoted to Grade II prior to such date will be promoted to Grade I from the date they complete a period of 12 years of active and satisfactory service in Grade III and II and all other qualifications referred to under 10.2.1.1 excluding the qualification in 10.2.1.1(i).
