<u>Appeals with regard to the Annual Transfers of the Officers in</u> <u>Sri Lanka Administrative Service (Grade I, II, III) – 2019</u>

Reference the annual transfers of the officers in Sri Lanka Administrative Service made in year 2019.

2. The decisions of the Board of Appeal with regard to the said transfers are submitted herewith.

3. All the transfers which have not been changed as per the decisions of the Board of Appeal shall also come into effect from the 01.02.2019. Further you are kindly informed that action will be taken to make the replacements relevant to the posts held by the officers who are promoted to Grade I of Sri Lanka Administrative Service and still serving in the posts of Grade II/III and subjected to annual transfers at present.

4. Accordingly, you are kindly informed to release all the officers who are subjected to transfers from the present service station enabling them to report for duty at new service stations on the relevant date without waiting for the replacements to report for duty.

5. In such case where an officer who has received a transfer order in the due manner on an annual transfer order, does not report for duty at the new service station, action should be taken by the Head of the Department/ Institution to which the officer has been transferred, to issue the notification of vacation of post as per the Section 217 of the Procedural Rules of Public Service Commission.
