- In such case where an officer who has received a transfer order in the due manner on an annual transfer order, does not report for duty at the new service station, action should be taken by the Head of the Department / Institution to which the officer has been transferred, to issue the notification of vacation of post as per the Section 257 of the Procedural Rules of Public Service Commission.
