The officers should be informed that the appeals received after that date will not be considered. Further it should be noted that the appeals, in which the file number mentioned against the officer is not included, will not also be considered.

04. You are requested to release officers, who have been transferred outside your Ministry/Department/Provincial Council/Institute **without retaining them until their successors report for duty** and enabling them to assume duties at new service station on due date.

05. In cases where the names of the ministries have been revised by the time the annual transfers are implemented, the transfer should be implemented in respect of the relevant post in the ministry where the officer, who is the replacement, serves at that time.
