இலங்கை திட்டமிடல் சேவை உத்தியோகத்தர்களின் 2025 ஆம் ஆண்டிற்காக செய்யும் வருடாந்த இடமாற்றத்துடன் இணையப் பெற்றது.

02. அவ் இடமாற்றங்கள் தொடர்பில் சமர்ப்பிக்கப்பட்டுள்ள மேன்முறையீடுகள் தொடர்பில் மேன்முறையீட்டு சபையின் தீர்மானங்கள் இத்துடன் முன்வைக்கப்பட்டுள்ளன.

03. அதன்படி, இவ் மேன்முறையீட்டு தீர்மானத்தின்படி மாறாத 2025.02.03, 2025.03.12, 2025.03.14 மற்றும் 2025.05.23 ஆகிய தினங்களில் செயற்படவிருக்கும் அனைத்து இடமாற்றங்களும் அவ் தினங்களிலும், மேற்கூறப்பட்ட தினங்களுக்கு பின்பு விசேடமாக தினங்கள் குறிப்பிடப்பட்டுள்ள இடமாற்ற சக்கரமானது அவ் தினங்களில் செயற்படும்.

04. அதன்படி, பதில் ஆளொருவர் சேவைக்கு அறிக்கையிடும் வரையிலும் வராத, இடமாற்றங்களின் கீழ் அனைத்து உத்தியோகத்தர்களும் உரிய தினத்தில் சேவை இடங்களில் கடமையை பொறுப்பேற்றுக் கொள்ளும் வகையில் தற்போதைய சேவை நிலையத்திலிருந்து விடுதலை செய்வதற்கு கருமமாற்றவென தயவுடன் தெரிவிக்கின்றேன்.

05. வருடாந்த இடமாற்றக் கட்டளையின் மீது இடமாற்றம் பெற்றுள்ள உத்தியோகத்தர்கள் புதிய சேவை நிலையத்திற்கு கடமைக்காக அறிக்கையிடாது இருக்கும் சந்தர்ப்பத்தில் அவ் உத்தியோகத்தர் இடமாற்றம் பெற்றுள்ள திணைக்களத்தில்/ நிறுவன தலைவரினால் அரசாங்க சேவை ஆணைக்குழு நடபடிமுறை விதிகள் பிரிவு 257இன் படி சேவையை விட்டுச் செல்லும் அறிவித்தலை வெளியிடுவதற்கு கடமையாற்ற வேண்டும்.

குறிப்பு - வருடாந்த இடமாற்றம் தொடர்பில் அரசாங்க சேவை ஆணைக்குழுவிடம் மேன்முறையீடொன்று சமர்ப்பிக்கப்படுமானால் 14 நாட்களுக்குள் இத்துடன் இணைக்கப்பட்டுள்ள v மாதிரிப்படிவத்தினை பூர்த்தி செய்து அனுப்புதல் வேண்டும்.
